



Storage Recommendations for Versiv Pressure Sensitive Adhesive Products

Versiv Composites Limited recommends that to maximise the shelf life of its products the following storage conditions should apply:

- Temperature ~ 20°C (16°C to 24°C)
- Relative Humidity ~ 50% (40% to 60%)
- Storage away from direct sunlight
- Clean dust and sand-free environment

Shelf Life:

Standard shelf life begins on date of manufacture. Minimum shelf life as follows:

6 months (182 days)	Silicone PSA Strip-N-Stick Tapes Silicone PSA on sponge sheet Silicone PSA on solid sheet Silicone PSA on silicone coated fabrics Silicone sponge primed for acrylic PSA Phase Change materials
6 months (182 days)	Semi cured and uncured materials stored at less than 7°C
18 months (550 days)	Silicone adhesive PSA tapes
24 months (730 days)	Rubber adhesive PSA tapes Acrylic adhesive PSA tapes Acrylic adhesive Strip-N-Stick Acrylic adhesive on sponge Acrylic adhesive on solid silicone rubber Acrylic adhesive on coated fabrics
5 years (1825 days)	Neoprene compound Gasketing 8016 & 8020
10 years (3650 days)	Non adhesive coated materials Solid Silicone Rubber Silicone Sponge Silicone Foam Silicone compound Gasketing 8516 & 8520 Silicone coated fabrics



The above shelf life is the minimum expected and stored correctly much longer life is possible. Should a Distributor or Distributors customer have a product where they have concerns over the effectiveness of the adhesive, we are always prepared to test product and compare results with the original manufacturing specification. The test sample should, ideally be at least 1" wide (25.4mm) and at least 24" (610mm) long.

Product that meets the manufacturing specification can have its shelf life extended for another six months. In some cases, if the product is very old and the adhesive is below the original manufacturing specification, we would not be prepared to comment on its future shelf life, but we would be able to make a judgement about its immediate use.
